Oct 2008 Atlantic Nursing Informatics Conference, Halifax

Even though it was 2 years ago, it's worth mentioning here. It was the best conference yet with the largest attendance to date. The theme was Improving Patient Care through Nursing Informatics. There were excellent pre-workshop conferences by June Kaminski (on Informatics) and Dr. Dawn-Marie Turner (on Change Management). The feedback on the conference was very positive.

Nov 2009 Canadian Nursing Informatics Association (CNIA) Conference, Mississauga

This exciting event brought together nurses from across Canada, as well as representatives from the American Nursing Informatics Association (AMIA). Keynote speakers created a dynamic foundation for the conference, and included Juliette Powell, Dr. Lynn Nagle, and Francesca Grosso. The theme of social networking supported a broad range of presentations that highlighted the diverse array of informatics applications and projects currently being implemented in Canada.

Eithne Reichart began her role as President at the Annual General Meeting, and shared a vision for greater collaboration with CNIA members and a desire on behalf of the Board to maintain closer communication with members.

A hot discussion topic at the conference was on creating a Nursing Informatics Certification program through the Canadian Nurses Association. At present, this does not exist in Canada. 
Who is an Informatics Nurse?

Three years ago, I only used a home computer for email and the occasional web search. Now, I can't live without it! All nursing documentation is now done on computer. Before the patient is seen, I can access the chart, previous admissions within our hospital, and pull lab results, all on line. I can determine if the patient should be assessed in the Preadmission clinic prior to surgery. It's fast and easy access. Information flows from the preadmission assessment into the pre-operative chart so there's no chance of losing the record. I have internet access to look up procedures, diagnosis and medications, all at my fingertips.

Sure, there are the occasional glitches where issues happen, after all, we're looking at multiple computer systems interacting more and more. Action from users in one system can affect another without them realizing the significance. It's opened up better communication and made us aware that we're all here to provide patient care.

Knowledge Workers

In a recent article in the Fall 2009 **Nursing in Focus** magazine, the article *Registered Nurses as Knowledge Workers* described the new paradigm for nursing practice in a quote by Porter O'Grady, 2003: the article states that a registered nurse is a knowledge worker who synthesizes information and knowledge and applies it to their nursing care.

Isn't that what nursing informatics is all about? As on our website, we have defined nursing informatics as how all nurses manage the information they collect so that it is meaningful and contributes to quality patient care.

The goal of nursing informatics is to get the...

- RIGHT information to the
- RIGHT people at the
- RIGHT time to do the
- RIGHT job at the
- RIGHT cost

So let's call a spade a spade. A knowledge worker (AKA registered nurse) is an informatics nurse. It all boils down to the same thing. It's what we do with this information, how we store it, transfer the information, use this information and how we apply it in our daily practice that we incorporate informatics within our nursing practice.
